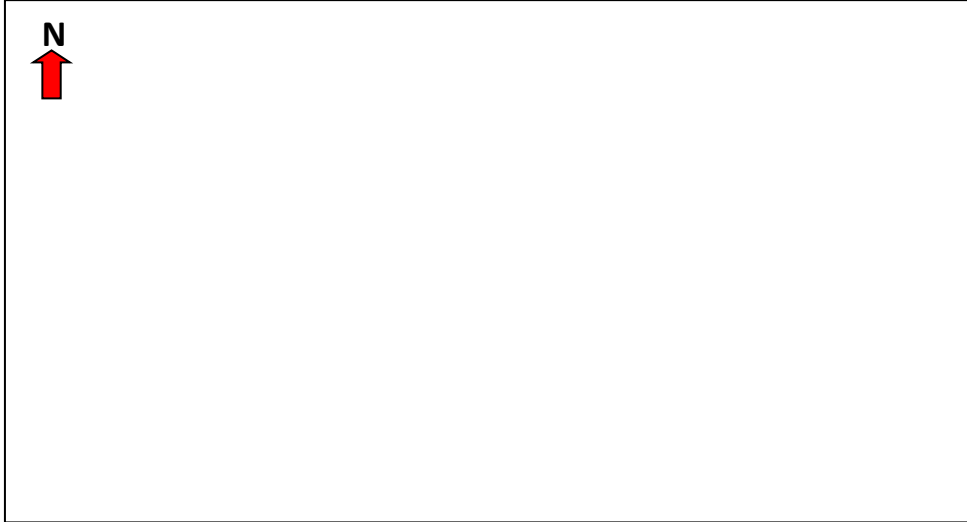

Project Funding/Cost – Responsibilities:

Landowner

1. **Agree to pay a \$100 service and administration fee prior to project completion.**
2. **Be responsible for the cost of removal of pump equipment, debris or obstructions prior to filling; if not able to, the work must be done by a licensed well drilling contractor, professional engineer, or professional geoscientist so that they may determine the necessary method required to properly seal the well.**
3. **Be responsible for the cost of a licensed well drilling contractor to fill in an artesian well.**
4. **One application per well sealing, even if well is located on the same property.**
5. *Cover costs not normally associated with well filling such as removing non-well related debris from site.*
6. *Indemnify and save harmless the District from any and all actions, claims, suits, damages, injuries, or other loss no matter howsoever arising as a result of the construction, operation or maintenance of the project.*
7. **By signing this application, the landowner agrees this is the landowner's agreement upon approval of project.**

Watershed District (WD)

1. *Provide contractor and all materials necessary for sealing (and removal of old cribbing/casing) abandoned well(s).*
2. *Ensure all required permits and agreements are in place prior to project start.*
3. *Supervise contractor and/or project to ensure well is properly sealed.*
4. *Complete any maintenance required for 1 year following project completion date.*

The Landowner Shall:

- **Allow consent of entry onto property for purposes of the project;**
- Provide access for inspection or evaluation by the Watershed District at any reasonable or future time;
- Not alter, change, remove or modify the project without written consent of the Watershed District;
- Ensure agricultural use and practices do not alter or affect the integrity of the project;
- May allow the District to place signage at the project site – signage removal must be approved by the District prior to removal;
- Indemnify and save harmless the District from any and all actions, claims, suits, damages, injuries, or other loss no matter howsoever arising as a result of the construction, operation or maintenance of the project, and;
- Grant the Watershed District the right to use any information related to this project for educational or promotional purposes.

The Watershed District Shall:

- Determine application priorities;
- Arrange for necessary equipment for excavation; and
- Reserve the right to reasonable access to project areas for tours, educational purposes or to inspect the condition of the project site at any time following completion of the project.

I hereby declare that I have read the conditions of this agreement, and that I agree to abide by the terms listed above. I further agree to cooperate to the fullest extent with the Watershed District Board and staff in completing and maintaining the project as outlined.
