3. To operate the Equipment according to the Standard Operating Procedure (SOP) instructions, a copy of which has been provided to the Recipient.

5. To allow SLWD access at any reasonable time, to inspect the Equipment and view its state of repair.
6. To assume all risk of any injuries, including death, loss or damages, be it personal or property that the Recipient, its servants, agents or anyone claiming through the Recipient, may suffer from the use of this Equipment rented by SLWD and acknowledges that SLWD will not be liable for the same.
7. To indemnify and save harmless SLWD from and against and be responsible for any action, claims, damages, loss, costs, expenses and disbursements including solicitor's client and administration fees, whether by way of judgment or compromise or settlement which SLWD may suffer, arising directly or indirectly from the granting of this Equipment loan, whether by performance, omission, default or remedying of such performance or default by the Recipient.
8. That the Equipment has a replacement value of \$8,000.00.
